At this time, we have had no reports of any additional crimes or incidents involving these individuals. It is our hope that these individuals no longer pose a threat to our children and our community.

While the staff at our school will be explaining and teaching your child the relevant safety measures that they should know, please take this opportunity to contact us for other resources that you may be able to utilize at home with your child. 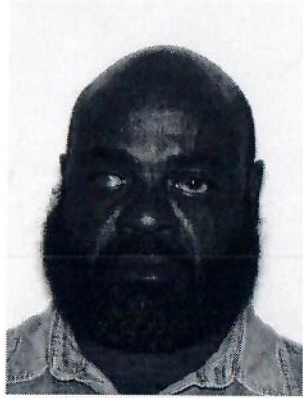

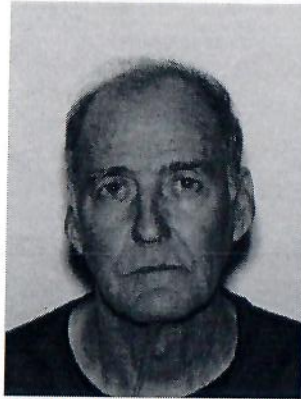
